- c. Artwalk SF: This is a monthly community event that connects neighborhood businesses with local artists and musicians. Events are held on the first Saturday of the month. from 12 PM to 5 PM. The event occurs at a different neighborhood each month. The GPMA has suggested holding the event in Glen Park in October 2023.
- 2. **Janet Tarlov: Birdseed / Rodent update:** Canyon Market is rodent free and vigilant, but the rodent population in Glen Park is still of great concern. The Birdseed Lady is still active and has been observed dumping birdseed along the Muni 44 bus line. The intersection at Silver and Mission has some bird carcasses and a lot of bird droppings, which can be tracked into the nearby Jewish Home.

  - b. Action: Janet will try to get on the agenda for the next Health Commission meeting. She has proposed forming a task force to address the problem and is inviting someone from the GPA to join, as well as SFPD and BART.
