Chenery Slow Street (Charlie Toohey, John Biasatti, Kathleen Tracey)

- New petition opposing the slow street has 467 signatures
- Two requests were presented:
 - #1: Will the GPA board write an official letter to SFMTA opposing the slow street, or
 - #2: Will the GPA board write an official letter to SFMTA stating our neutrality on the issue
- The board discussed the options. Heather moved that we send SFMTA a letter stating our neutrality regarding the Chenery Slow Street. Mary seconded. MSP A draft will be sent to the board for approval by Friday.

Elk / Sussex Crosswalk (Cory Malnarick, Elk Street Neighbor):

- Emailed us an update on his communication with SFPD Acting Captain Knoble, who
 visited Malnarick at home to evaluate traffic conditions on Elk, including problems with the
 new crosswalk on Elk at Sussex. According to Malnarick, Knoble said the police
 department is understaffed and assigning officers to traffic would take time away from
 more important matters. The Lieutenant emailed District 8 SFPD liaison David Burke
 about Chenery and Elk, Elk and Bosworth, and the new crosswalk causing traffic issues
 at Elk and Sussex.
- David responded saying three things:

- Traffic enforcement is Knoble's responsibility
- Changes to the streets fall under MTA's purview
- He CC'd Zahra Hajee from Supervisor Mandelman's office to help out with facilitating a meeting regarding looking at these intersections given our concerns
- Steve Green to follow up on the crosswalk with SFMTA and Public Works. Copy Dan Wright and Sal Novoa.

District 8 Mixer (Heather):

 Representatives from a half dozen neighborhood associations from District 8 gathered for a meet-and-greet May 9. This first meeting was just an introduction, but there promises to be more events in the future, as everyone attending felt that was in the neighborhood's best interest.

Dear SFMTA Board and Staff,

The Glen Park Association wishes to clarify our position on reinstating Chenery as a Slow Street. Given strong neighborhood support and opposition, <u>our Association is neutral on this issue</u>, and we urge SFMTA to evaluate Chenery as a Slow Street based on data and community engagement conducted by SFMTA.

On January 14, 2023 we submitted a letter in which we wrote that, "we suggest that interested neighbors and SFMTA staff meet to discuss the path forward" in reinstating Chenery as a Slow Street. The "path forward" that we advocated for was one that SFMTA assured us would involve neighborhood engagement and traffic studies. Unfortunately, we have been disheartened to learn that SFMTA has not conducted significant outreach nor studied the impact of traffic diversion away from Chenery Street.

Further, since we submitted our January 14th letter, we have learned of significant opposition from neighbors and have received a copy of a petition in opposition. As a result of receiving this new information, we wanted to clarify that the Glen Park Association does not support or oppose Chenery as a

Slow Street, and we strongly feel that SFMTA should evaluate Chenery as a Slow Street based on traffic studies, data and SFMTA-led community outreach.

We believe any change in traffic patterns in Glen Park should make the neighborhood as a whole safer and more communal.

On February 22, 2023 we also wrote a letter supporting an SFMTA grant application that would bolster street safety. In this letter, we mistakenly identified Chenery as an existing Slow Street. We regret any confusion this error may have caused. SFMTA has since assured us Chenery need not be a Slow Street for the grant to be successful.
