- 5. Fiscal sponsorship
 - a. Renee Berger has asked the GPA to be a fiscal sponsor for the Bosworth Pedestrian Bridge Project, since Parks Alliance has dissolved. Per Dennis, being a fiscal sponsor is a complicated process and requires a dedicated person, thus the GPA cannot become a fiscal sponsor. Carolyn D will send Renee a list of potential fiscal sponsors.

8. Committee reports

- a. Treasurer (Dennis)
 - i. \$12,849.27 as of May 31, 2025, in Tri-Counties
 - ii. \$15,000 approx in BofA account that is being moved over but no credit card but can do online banking
 - iii. \$2,000 approx in Chase but gave us a credit card
- b. Membership (Hllary)
 - i. 169 members; waiting on checks from 2
- c. Neighborhood improvement (Carolyns W & D)
 - i. There was a work party at Lyell / Bosworth as part of the D8 day.
 - ii. A group from Stanford worked on the lower path of the 500 Arlington block
 - iii. There was also a cleanup at the Bosworth pedestrian bridge
- d. Rec & Park: There was a complaint about dogs running free; referred to Chris Faust at UNN
- e. Greenway: (Carolyn D) A new fiscal sponsor is needed since Parks Alliance has folded. The Greenway project has/had \$22K with Parks Alliance and the company that did the apron is owed \$10K. Possible resolutions were discussed and hopefully this can be resolved once a new fiscal sponsor is obtained. The July 12 workday might have to be cancelled due to loss of insurance (PA) unless the GPA can pay for one day of insurance.
- f. Transportation (Steve)
 - i. Dan Goldes emailed the city re stop signs that are ignoredNo right on red that are ignored:
 - Diamond and Bosworth
 - Diamond at Monterey

Stop signs that are ignored:

- Brompton at Joost (next to Glen Park School)
- Joost at Monterey (half a block from Glen Park School)

- Arlington at Bosworth
- Arlington, Wilder, and Natick (all of the stop signs here are regularly ignored, including one coming off San Jose Avenue, with people traveling at near highway speeds)
- ii. X Kaestner is a new member of the committee
- iii. Painting has been done at crosswalks and the freeway entrance, showing that SFMTA has listened and responded to the neighborhood concerns.
- g. Safety: A neighbor reported an assault. We referred him to Dave Burke and Ingleside SFPD.
